- b. Tuition Bills - Copies were in the board packets. The bill for this upcoming school year will be about the same as the 2008-2009 school year.
- c. Consider Discussion of Baseball Storage Shed/Concession Stand
  - Towards the beginning of the year the coaches approached sports boosters about a shed to lock up equipment by the baseball field. Sports boosters have began work on this storage shed/concessions stand. So far they have put \$1000 into it from their own money. They plan on paying for the rest of the materials and man hours have been volunteered to finish the building. Sports boosters would like the district to pay \$4734.07 to cover the trenching and running of water and electricity to the building. Mrs. Snyder's concern is that we don't have the money to pay for education supplies but we are going to put money into this building. The other concern was that sports boosters did not ask before the building process was done.
  - The motion was made by Mr. Cox, seconded by Mr. Boyles to approve that he district pay \$4734.07 towards the building to pay for trenching and running electric. Vote: 5-0. Mr. Knipe and Mr. Sinele – Abstain.
